The Project

- Applicant / Developer: Purfleet Centre Regeneration Limited (PCRL)
- Location: Purfleet-on-Thames
- Regeneration Scheme:
 - 2,850 new homes
 - World-leading film and television complex
 - New town centre
 - New train station and bridge crossing
 - New Primary and Secondary schools
 - An Independent Medical Centre (IMC)
 - Vital business, retail, education and community infrastructure.
- Vision to open-up Purfleet-on-Thames' river frontage, provide much needed housing and create employment and educational opportunities to drive growth in support of its potential as a regional centre of creative industry.
- Approach Collective design development process shaped by the Purfleet-on-Thames Community Forum and Design Panel in consultation with local residents.





Proposed Green Infrastructure

The green infrastructure strategy for Purfleet Centre Regeneration looks to connect the site with the wider ecological context.

The Greenway is an important Green Infrastructure link and part of a large connected network of green elements.

Both the railway corridor and the woodland allow the mouvement of species. It is linking the edge of the Thames up to Tank Lane and towards the Mardlike River.

The vision apropach creates the opportunities for this area to makes smaller green connection into the new communities and to be open to the public.



ZONE 1_ GREEN CONNECTOR

GREEN CONNECTOR area is the link between the Civic Centre and the ECO-PLAY PARK. The purpose if this area is to emphasize the natural movement in the meadow.



Existing Levels

Proposing a level plateau of +5.0m for the area of Z1Di. This is the maximum consented parameter height for the majority of this zone and puts it at the same level as the green square.





THE GREENWAY

ZONE 2_ ECO-PLAY PARK

The ECO-PLAY PARK area equals a city garden with more community activities, playground and with close proximity to the Village School, has the potential of becoming the extension of the educational programs.

Key elements:

- Woodland buffer planting
- > Woodland-themed playground
- > Natural discovery play
- > Incidental seating

- > Natural amphitheatre seating / outdoor classes





Existing Levels

The embankment is pushed as close to the boundary of the site as possible, creating a +8.0m greenway plateau with the cycle lane cutting across the rise of the embankment to gradually ascend up to the primary road at +13.0m. The townhouses step down to +7.0m at the secondary road.



Development to commence 2022




Phase 1

Current levels within the industrial estate are not appropriate for a modern, accessible mixed-use development.

Regrading has always been necessary to:-

- allow roads & pavements to be broadly level and usable.
- allow gravity drainage to work.
- provide a flood defense barrier along the side of the railway line.
- provide the 'Greenway' cycle & pedestrian route








